It focuses only contraception rather than safe practice to ensure young people understand how to look after their bodies - yes this can be taught in a sensitive way to KS2 and above.

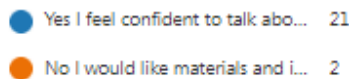

You've mentioned celibacy but not homosexuality. As a parent in a same-sex relationship, I don't want my son to think our relationship is not valid. He has already told us that some of his classmates tell him boys can't marry boys which is just obviously not true in this country whatever your religious beliefs. I can see acceptance of different types of families is mentioned throughout, but to not mention it in that section at KS2 reinforces a position that it's not normal.
